

## PTS REMEMBERS FORMER BOARD CHAIR BOB HARPER



Pittsburgh Theological Seminary remembers Robert “Bob” T. Harper, former chairman

of the Board of Directors, who died Feb. 27, 2012 following his battle with cancer.

“Bob served faithfully on the PTS Board of Directors from 1996 through 2007. For five of those years, 2001 to 2006, he served with enthusiasm, humor, and decisiveness as Chair of the Board. He was a good friend and colleague in ministry who will certainly be missed by many both here and around the country,” said the Rev. Dr. William J. Carl III, president and professor of homiletics.

Harper was an attorney with Klett Rooney Lieber & Schorling when it merged with Buchanan Ingersoll in 2006. At Klett Rooney, he served on the firm’s board of directors, was vice president of administration, co-chairman of the firm’s Corporate practice group, and chairman of its Health Law practice group. Upon joining Buchanan, he served as co-chair of the Health Care Section.

He was listed in The Best Lawyers in America for Corporate Law and Health Law listed for 17 consecutive years. Harper frequently spoke for the American Bar Association, the National Institute on Mergers and Acquisitions, and the Pennsylvania Bar Institute on corporate law matters, including business acquisitions and takeovers, and a variety of health care matters. Since 2006, he was consistently selected to the Pennsylvania Super Lawyers list.
