COURSE DESCRIPTION:

This course explores the communal, intercultural, and systemic contexts of caring practices and the links between justice-making and pastoral care. In this course students will consider the ways in which communal dynamics such as injustice, exclusion, and conflict may shape individual experiences of suffering, both in congregations and in the communities of which they are a part.

CLASS OBJECTIVES:

By the end of this course students will be able to:

- Articulate an understanding of pastoral care as a form of ministry that is situated within complex organizational and cultural systems;
- Narrate how this understanding challenges, supplements, or transforms students' ideas about the nature of pastoral care;
- Integrate insights from the course material with reflections on students' own pastoral care experiences in ministry, with particular attention to the various *contexts* in which such experiences are taking place; and
- Describe their own emerging understanding of the proper relationship between practices of justice-making and practices of pastoral care.
